National Health Mission (NHM), Rajasthan State Health Society, is inviting applications from eligible candidates for position of Public Health Manager at urban PHC level purely on contractual & temporary basis wide Public Notification No: F.2 (172) NUHM/HR/2017/392 dated 10/10/2017 under National Urban Health Mission (NUHM) Rajasthan.

- All above mentioned Master Degree / Post Graduation Degree / Post Graduation Diploma done by candidates must be of minimum two years and should be duly approved through UGC / AICTE / Universities / Recognized similar Bodies.

(A) Application form submission :

- Clearly mention the name of post applied for on application form and envelop.
- Application form must reach in prescribed format only with the self attested photocopies of following documents:
 - Completely filled and signed application form in prescribed format
 - Educational certificates and mark sheets of related essential qualification
 - Mark sheet / Certificate of Xth standard as age proof document
 - Address Proof (Voter ID / Driving License/ Aadhaar Card - Any one)
 - Certificate of reserved category:
 - a. Caste Certificate (OBC/ SC/ ST)
 - b. Horizontal Category Certificate : Physically Handicapped / Ex-Serviceman/ Sports Person
 - c. Certificate of TSP area resident (special bonafide certificate)

Note: OBC candidates must submit latest certificate and it should not be older than six months as on 01.10.2017


